CONDITIONS

The conditions of registration with The Beer Store as a Commercial Hauler are:

- Commercial Haulers will only return to The Beer Store empty Wine/Spirit/Beer Containers, hereafter referred to as "ODR" (Ontario Deposit Return) containers, for which a deposit has been paid for in the Province of Ontario on or after February 5, 2007.
- Once registered with The Beer Store, all subsequent returns to any Commercial Return Location must be completed with the assign Commercial Hauler registration number only.

3. Commercial Haulers will return ODR containers to Commercial Return locations only as designated by The Beer Store (See Commercial Return Location List). Prior to returning empty ODR containers, please contact the nearest Commercial Return location to setup an appointment.
4. Commercial Haulers will provide to The Beer Store a list of locations for which the Commercial Hauler is collecting ODR containers. Commercial Haulers must update The Beer Store on changes to the Commercial Hauler collection locations list as required or as requested by The Beer Store.
5. Information on Commercial Hauler container returns and customer list may be provided to ODR Government Program Auditors for enforcement purposes. By signing this registration form, you are agreeing to such disclosure for government audit purposes.
6. All empty ODR containers will be verified by the Beer Store and payment adjustments will be completed by The Beer Store where variances are noted. The Commercial Hauler will be notified of any payment adjustments.
7. Commercial Haulers must segregate ODR containers according to the sorting procedures prescribed by The Beer Store outlined in the following documents:
 - Empty Container Return Requirements
 - Case Piling and Palletizing
8. Knock-down cartons will be available for purchase at The Beer Store in order to assist with the Return requirements.

PAYMENT

1. Commercial Haulers will be paid for the total value of deposits as per the below rate chart:

2. The Beer Store reserves the right to change the rate sheet listed above if the Deposit Value(s) change for any of the Deposit Categories listed in the above chart.
3. You will be paid by either Electronic Funds Transfer (“EFT”) or by cheque that will be mailed to the address provided above. For EFT payments, you must complete an Application for Direct Deposit and provide a void cheque.

TERMS

This Agreement shall be effective upon execution hereof by authorized representatives of The Beer Store and The Private Bottle Reseller and may be terminated by either party with written notice.

MISCELLANEOUS

This Agreement constitutes the entire agreement and supersedes all prior agreements, understandings or arrangements, oral or written, between The Beer Store and The Private Bottle Reseller.

No variation of or supplement to this Agreement shall be effective unless The Beer Store and The Private Bottle Reseller have agreed in writing and have respectively obtained the required authorizations and approvals.

Any notice, request or other communication to be given or made under this Agreement shall be in writing.
